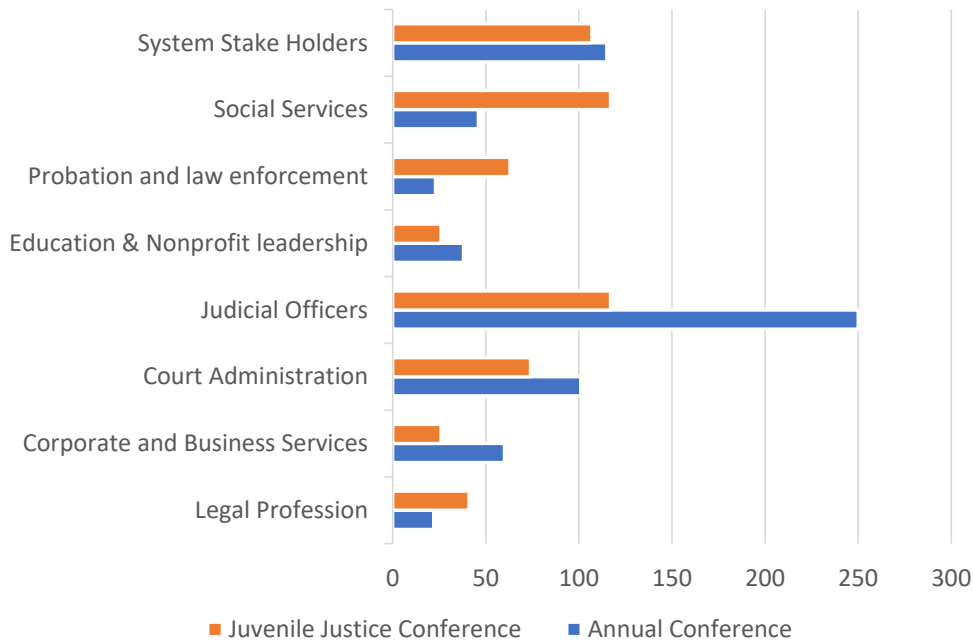

 (session topic percentages presented in 2024)

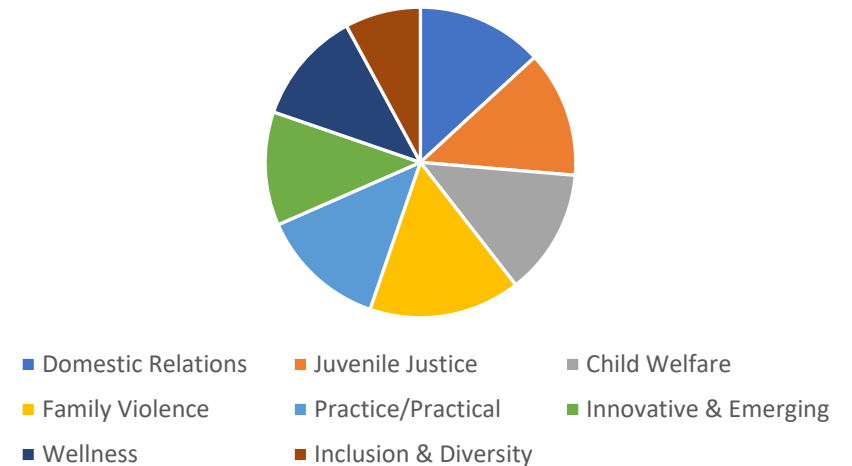
