- Five years of experience working in the area of domestic or family violence and/or working in a non-profit, federal grant-funded environment preferred
- Behavioral health service coordination or systems advocacy, court services and/or court management
- Degree from an accredited four-year college or university; study in the area of women's studies, political science, social work, or adult, or jurist doctorate education preferred
- Ability to help develop, manage, and track compliance of grant deliverables/budgets
- Experience coordinating with staff, program partners, and consultants in developing and implementing programs and curriculum for adult learners
- Skilled at delivering prompt and friendly customer service to judges, attorneys, federal and national partners, subject matter experts, and staff, including NCJFCJ leadership and Board
- Familiarity with updating publications and providing technical assistance for workshops and training sessions in a timely and efficient manner
- Strong PC-based computer skills
- Familiarity with virtual learning platforms, including Zoom
- Effective communication skills, both verbally and in writing

- A passion for working in a non-profit, grant-funded environment
