Description: NCJFCJ serves as BJA's training and technical assistance provider for all court-centered Byrne SCIP activities. Please join this Office Hours session to ask questions and learn about the array of opportunities available to courts to enhance their response, using Byrne SCIP funding and TTA, to individuals in crisis and to address the safety and behavioral health needs of court-involved individuals.

NCJFCJ can help State Administering Agencies, SCIP advisory boards, state court administration and local courts at any level of their Byrne SCIP activity, from project conception and planning to training, policy development and program implementation. Examples of the types of court-centered programs for which NCJFCJ can provide assistance include:

- Treatment courts (including developing programs that can serve individuals with violent criminal histories).
- Innovative strategies to address firearms risk across court dockets.
- Innovative court responses to domestic violence, including integrated civil/criminal/family courts and courts integrating safety, compliance and treatment approaches.
- Incorporation of behavioral health professionals and peer-support specialists in courts across all dockets.
